- ☐ Head of each PO: Always a Region or a Municipality













END RECIPIENTS

- □ Eligible End Recipients:
- Beneficiaries of Guaranteed Minimum Income Scheme (registered End Recipients)
- > People served by soup kitchens (nonregistered End Recipients)
- □ Registered End Recipients: 300.000 members on average per month (min. 180.000 max 450.000) updated every month
- ☐ Total number of served End Recipients for the whole PP: 1.500.000 unique social security numbers

DISTRIBUTED ITEMS

FOOD

□ 38 kinds of fresh products (meat, poultry, dairy vegetables, fruit)

☐ 39 kinds of dry products (including baby food)

20% protein, 25% dairy, 43% carbohydrates, 12% fruits and vegetables















DISTRIBUTED ITEMS

BASIC MATERIAL ASSISTANCE

- ☐ 28 types of basic material assistance
- > personal hygiene items
- > household cleaning products
- > baby and child use and care articles (hygiene and school items)
- > articles for the elderly (diapers) and the homeless (hygiene kit)
- personal protective equipment against COVID-19 (protective masks, disinfectant gels).











MEALS

Food stock which has not been picked up by End Recipients is forwarded to soup kitchens or meal centres.

The calculation of the generated portions is based on a calculation tool included by the Managing Authority in the Indicator Performance Form Completion Guide.

The stock for the whole PP 2014 - 2020 provided 15.877.350 meals.


☐ Number of Services: 250.391

- > Psychosocial support, empowerment and social integration of adults and children
- > Nutritional counseling
- > Family budget management counseling
- > Social tutoring schools

- □ An Integrated Information System for monitoring inputs and outputs of End Recipients and products (physical implementation)
- ☐ An Integrated Information System for monitoring the expenditures (financial implementation)











SYNERGIES OF FBMA OP WITH OTHER SCHEMES

- **Guaranteed Minimum Income**: On 1st June 2021 the implementation of the third pillar of the Guaranteed Minimum Income (in Greek abbreviated as EEE), concerning the forwarding of the EEE/FEAD end recipients to active employment policies started.
- Article 11 of number D13/oik. 42815/24.06.2021 Joint Ministerial Decision "Definition of the terms and conditions on the implementation of the "Housing and Labour for the Homeless" programme (Official Gazette Sheet B' 2788): The end recipients of the national programme against homelessness titled "Housing and labour for the Homeless" program are supported through FEAD to meet their basic subsistence needs after exiting the "Housing and Labour for the Homeless" programme and becoming eligible for EEE.
- FBMA OP, in synergy with **the Guarantee for the Child Initiative** adopted by the EU in 2021, intervenes in child poverty, both through food aid (distribution of baby and child food, package composition according to the number and age of children in the household), and the specific accompanying measures it implements.

ESF+ - Specific Objective 13

Priority 6

- □ Integration of FEAD into ESF+: In order to rationalize funding and create additional opportunities for synergies through integrated funding approaches
- □ Specific Objective 13: Addressing material deprivation by providing food and/or basic material assistance to the most deprived, including children, and accompanying measures to support their social inclusion
- □ ESF+ actions are implemented through the "Human Resources and Social Cohesion Programme", where specific objective 13 becomes "Priority 6 Food Aid & Material Deprivation".
- ☐ Budget: Euro 400,000,000
- ☐ Beneficiaries: The 13 Regions of Greece
- ☐ End Recipients: GMI Beneficiaries and people in need defined by Ministerial Decision
